

**Potomac Garage Sweepstakes  
OFFICIAL RULES**

**ELIGIBILITY: NO PURCHASE NECESSARY TO ENTER OR WIN.** Potomac Garage Solutions Sweepstakes (the "Sweepstakes") is open to legal residents of the United States (except Puerto Rico, Guam, U.S. Virgin Islands, and all other U.S. and foreign territories and possessions, and excluding where otherwise prohibited by law, rule or regulation), who are 18 years or older at the time of entry.
